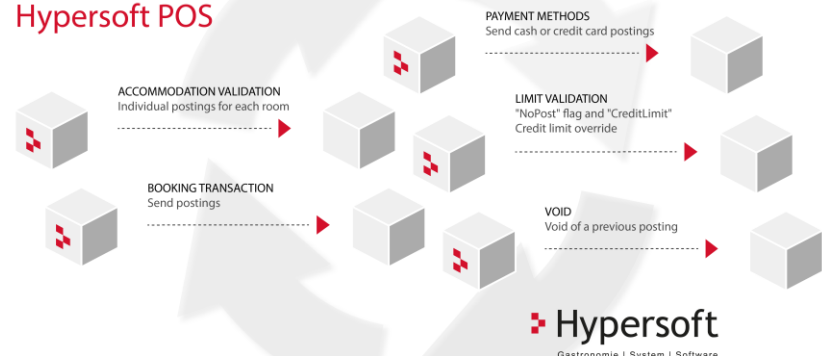

- Send room postings to Oracle Hospitality OPERA PMS.
- Send Cash or Credit card postings to Oracle Hospitality OPERA PMS.
- Ability to handle "NoPost" flag and "CreditLimit" received from Oracle Hospitality OPERA PMS.
- Credit Limit Override functionality supported; allowing a POS manager to override any credit limit set on Oracle Hospitality OPERA PMS.
- Handling of individual postings for each occupant in the room.
- Void of a previous posting.
